Topic: Enrollment details for IEP Secondary 4 quota students

Dear: Parents/Guardians

On behalf of the International Education Program for Basic Education, Piboonbumpen demonstration school, Burapha University, I would like to inform you of the enrollment details for Secondary 4 of the International Education Program for Basic Education in the academic year 2026. Details of enrollment are as follows:

### 1. Parents

Parents must bring students to report. Parents must be of legal age and have names in the same house registration as the students. In the case of parents or guardians who are not in the same house registration, a power of attorney from their parents must be presented on the day of the report.

### 2. Date of Enrollment

Friday, February 20, 2026. Between 09:00 AM – 03:00 PM (Lunch break, 12:00 PM to 01:00 PM) at the IEP building, Academic Affairs office.

### 3. Required Documents

3.1 Two 3x4 cm. photos taken within 6 months

3.2 A copy of the birth certificate

3.3 A citizen ID of the student / A passport copy for Non-Thai Students

3.4 A house registration book copy (for Thai Students)

3.5 A citizen ID of the father (Thai).

A passport copy of the father (Non-Thai)

3.6 A house registration book copy of the father

3.7 A citizen ID of the mother (Thai).

A passport copy of the mother (Non-Thai)

3.8 A house registration book copy of the mother

3.9 A citizen ID of guardians (Thai) A passport copy of guardians (Non-Thai)

(In the case that guardians are not parents)

3.10 A house registration book copy of the guardians

(In the case that guardians are not parents)

- 3.11 A marriage certificate copy (if any)
- 3.12 A divorce certificate copy (if any)
- 3.13 A legitimization of a child certificate copy
  - (In case parents do not register the marriage, and the father is the guardian)
- 3.14 A name/surname change certificate, copy of students (if any)
- 3.15 A name/ surname change certificate, copy of parents (if any)
- 3.16 A medical certificate (only original documents)

Article 3.2 – 3.15 must be signed to certify a true copy by the owner of the document.

#### **4. Payment of fees and other expenses**

- 4.1 Pay fees in accordance with the regulations of Burapha University.

The collection of maintenance fees and other expenses from the Demonstration School students "Piboonbumpen", BE 2015, Basic International Education Program, 1st installment, Total amount 75,000 baht (Seventy-five thousand baht), Non-refundable in any case.

- 4.2 Lunch fee per semester 5,650 baht

(Five thousand six hundred fifty baht)

- 4.3 Orientation Activity fee 5,500 baht

(Five thousand five hundred baht)

**Total Amount 86,150 baht (Eighty-Six Thousand One Hundred Fifty baht)**

*\* This payment of fees and other expenses does not include the textbooks and notebooks.*

#### **5. Payment methods**

5.1 The payment should be deposited through Teller Payment, which can be downloaded from [www.st.buu.ac.th](http://www.st.buu.ac.th). The payment should be made on **February 16 – 18, 2026, only**.

5.2 The payment should be deposited through Teller Payment in any Krung Thai Bank branch in Thailand. A service charge of 10 baht/student will be charged in the bank upon payment.

5.3 Any payment made should be accompanied by a school Teller Payment Form. Please make sure the Teller Payment Form is signed and stamped; otherwise, it will not be considered a receipt. You can download from [www.st.buu.ac.th](http://www.st.buu.ac.th)

#### **6. Students must not be in arrears with tuition fees and other school expenses on the date of enrollment.**

7. Students who have successfully registered but wish to relinquish their place and request a refund later, the school reserves the right to refund only the lunch fee. You may request a refund until April 30, 2026. After this deadline, no refund will be given for the lunch fee under any circumstances.

8. Students must behave in a manner that does not violate the school regulations on student conduct, dress code, student punishment, and conduct score rules until the enrollment date.

9. Students who do not enroll on the date and time that the school determines will not receive admittance.
